

# **Terms and Conditions for visiting Hunt Country Vineyards**

*Updated 6/10/20*

**1. I am aware of the current COVID-19 pandemic and the contagious nature of the virus.**

**I understand and accept the risks associated with visiting public places during a pandemic.**

Legalese: I acknowledge the contagious nature of the COVID-19 virus and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by visiting or participating in wine tasting at Hunt Country Vineyards and that such exposure or infection may result in personal injury, serious illness, permanent disability or death. I understand that the risk of becoming exposed to or infected by COVID-19 at Hunt Country Vineyards may result from the actions, omissions, or negligence of myself and others, including but not limited to Hunt Country Vineyards, Hunt Country's employees and other Hunt Country visitors.

**2. I affirm that, to the best of my knowledge, I do not currently have an active case of COVID-19. I have not tested positive for COVID-19. Or I have recovered from COVID-19 and been cleared by a competent medical professional as no longer being a risk of spreading the disease.**

**I affirm that I have not been in close contact with a person who is confirmed or suspected of having COVID-19.**

**I affirm that I have not had any of the following symptoms within the past 14 days: coughing, shortness of breath or difficulty breathing, fever, chills, muscle pain, sore throat, new loss of taste or smell.**

**I will not participate in wine tasting at Hunt Country if I have any of the above conditions or symptoms.**

Legalese: I am not aware that I have any health conditions that are known to increase my likelihood of experiencing injuries or make me more susceptible to illness while engaging in this activity. I specifically acknowledge my obligation to participate only if I am experiencing no symptoms identified by the Centers for Disease Control and New York Department of Health.

**3. I understand and accept the risks associated with failing to practice both recommended and required social distancing guidelines, sanitation and hygiene, or other pandemic-related guidance.**

**I follow the practices put in place by Hunt Country Vineyards. I will follow the directions given to me by Hunt Country staff.**

Legalese: I will comply with the social distancing, hygiene and sanitation practices that Hunt Country Vineyards has put in place. I acknowledge and agree to take appropriate precautions, including maintaining good personal hygiene including frequent hand washing or sanitizing and staying at least six feet from persons not in my party or related to me, other than Hunt Country Vineyards hospitality personnel. In addition to following all precautions established by Hunt Country Vineyards, I will take all steps necessary to reduce the risk of illness to me and my party.

**4. I will not hold Hunt Country Vineyards liable in the event that I become infected with the virus.**

Legalese: I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself, including, but not limited to, personal injury, illness, disability, death, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my visit to or participation in wine tasting at Hunt Country Vineyards ("Claims"). I hereby release, discharge, covenant not to sue, and hold harmless Hunt Country Vineyards, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Hunt Country Vineyards, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after my visit to or participation in wine tasting at Hunt Country Vineyards.
